b) Marshals will sign on in the Paddock suite 34/36 on the ground floor of the Woodcote suites to the left of the national race control building, using the times given below. Internal parking is very limited so where possible please park at Copse outside and walk through the tunnel to sign-on. There will be no parking at the Wing so minibus transport will be provided to transport pit marshals with shuttle busses for all other Wing access.

### **6. NOTICE BOARD:**

The official noticeboards are located on the wall at the foot of the Race Control building at the Wing or National Race Control.

### **7. BRIEFINGS:**

Drivers will be informed by championship bulletin of their particular briefing time.

### **8. NOISE POLLUTION:**

Engines must not be run before 08:30 or after 19:00 on any day.

### **9. CIRCUIT ACCESS & EGRESS:**

WEC and WSV8 competitors will operate from the International pit lane in accordance with their championship regulations

ELMS competitors will operate from the National pit lane in accordance with their championship regulations

FIA F3, being based, in the National paddock will assemble and access the track near the National scrutineering bay before being led in convoy to the International pit lane for practice and qualifying and directly to the grid for races.

### **10. LIVE SNATCH:**

In the event that a vehicle needs to be moved trackside the Clerk of the Course has the option to carry out a "live snatch" under local yellow flags.

### **11. RED FLAGS:**

Any category which generates a "red flag" may be placed at the end of the schedule subject to time being available.

### **12. JUDGES OF FACT:**

Judges of Fact may be appointed in accordance with the current FIA Yearbook

## **13. CIRCUIT & MEETING NOTES:**

BARC will not be liable for any damage caused to vehicles being recovered from the track. Competitors who experience mechanical problems, particularly if that problem is likely to be a hazard to others, must be stopped immediately in a place of safety. The competitor may also be liable for any excessive clean-up costs involved. There are signal lights around the circuit and these lights have the same meaning as the flag signals. Motorsport is a non-contact sport and competitors who make contact with each-other render themselves liable to penalties in accordance with the current FIA Yearbook.

The circuit fuel station will be open during the meeting. All working areas should be kept clean and tidy and any waste placed in the appropriate container. Waste must not be mixed or waste left around the site. In the event that the BARC is charged for such issues then the charge will be passed on to the championship concerned if the individual cannot be identified.

Any person who is injured or feels unwell should seek help from the circuit medical services. Please contact an official or member of the venue management team.

## **14. MARSHALS MATTERS:**

Marshals camping will be at Winterhills which is located behind the UTC college building. Access is through the main gate, and then turn left to drive around towards Copse past the College building then through Gate 5. The campsite will have toilet and shower facilities and limited power hook-up on a first come first served basis. The campsite will be open from 12:00 on Wednesday 12<sup>th</sup> April and close at 9am on Monday 17<sup>th</sup> April.

Marshals will receive a food voucher at sign-on for use in the pit-stop or media cafes. The pit stop café will stay open to serve hot food each evening. On Saturday evening there will be a party, including a Hog Roast, in hall 1 of the Wing and all marshals are welcome to attend free of charge but a charge of £10 per person will be made if a guest comes along.

Post allocations will be advised at sign-on, please remember you should not use mobile phones or cameras while on duty

If you are unable to attend please contact Paula Brown and return your passes to the BARC.
